2015 Legislative Update

New Law Restricts Healthcare Solicitation

During the 2015 Legislative Session, the Kentucky General Assembly passed House Bill 153, which prohibits healthcare providers (including PTs and PTAs) or their intermediaries from soliciting a person who was involved in a motor vehicle accident for at least 30 days following the accident. "Solicitation" is defined in the statute as "the initiation of communication with a person involved in a motor vehicle accident, including but not limited to any face-to-face contact with the person, in writing, electronically, or by any form of telephonic communication, in anticipation of gain or remuneration for the communication itself or for prospective charges for healthcare." The term "solicitation" does not include any marketing or advertising directed to the general public.

The new law also requires PTs and PTAs to report any violations of this Act to Board if they have actual knowledge of a violation. Finally, the law states that any healthcare provider who violates this new law will be subject to the disciplinary process of their respective licensing board.

New Law Removes Requirements for HIV/AIDS Training

A new law passed by the General Assembly and signed by Governor Steve Beshear will remove the mandatory HIV/AIDS training requirement under KRS 327.050, 327.060, and 201 KAR 22:040. Under the prior law, all credential holders had to complete the course to receive an initial credential and had to re-take the course every 10 years.

The new law amends the language of KRS 327.050 and 327.060 and removes the requirement. Additionally, the Board is taking steps to likewise remove the corresponding requirements in the relevant provisions of the administrative code. The law goes into effect on June 24, 2015. NEW JURISPRUDENCE EXAM AVAILABLE

If you have already completed the exam, you will see "Congratulations" and you can download your certificate. If you are routed to the exam, however, you still need to complete it.

Telehealth in Physical Therapy Policy Recommendations for Appropriate Regulation

The Federation of State Boards of Physical Therapy ("FSBPT") recently examined the laws, regulations, and proposed legislative language for 53 licensing boards regarding physical therapy provided via telehealth technologies. While several jurisdictions were found to have generalized telehealth laws and regulations primarily designed to address other health related professions, which may apply indirectly to physical therapy treatment, FSBPT determined that only three jurisdictions -- Alaska, Kentucky, and Washington – currently have specific language regulating physical therapy practice using telehealth.

Therefore, in an effort to provide guidelines to physical therapists and physical therapist assistants who may be considering utilizing telehealth technologies in the delivery of client care, and to assist physical therapy boards which may be considering regulating the use of telehealth technologies in the practice of physical therapy, the FSBPT assigned its Ethics and Legislation Committee ("Committee") the task of drafting a resource paper that included policy recommendations for the appropriate regulation of telehealth. The Committee met and discussed this topic on several occasions over the past two years. Input from affected stakeholders and other interested parties was solicited and considered. Recognized authorities in this field, including the American Telehealth Association, the Federation of State Medical Boards, and the American Physical Therapy Association, were also consulted. Additionally, an educational program concerning telehealth in physical therapy was conducted at FSBPT's 2014 annual conference, with input offered by the attendees. Consequently, a final draft of this resource paper was submitted to FSBPT's Board of Directors for its review earlier this year, and in April of 2015 FSBPT approved the publication and distribution of this resource, formally titled "Telehealth in Physical Therapy, Policy Recommendations for Appropriate Regulation."

Recognizing the rapid and fluid growth in telehealth technology and applications, the Committee drafted this resource with broad-based principles in mind and in a manner intended to have future relevance without the need for licensing boards to continually amend their laws and regulations. Some of the important aspects addressed by this resource include:

- the provider's responsibilities attending the use of telehealth technologies
- verification of the client's identify
- obtaining the client's informed consent
- the point when a provider/client relationship is first developed
- guidelines for privacy and security when practicing physical therapy using telehealth technologies
- emergencies and client safety procedures

It is important to note that this resource was not intended to serve as model language for adoption by state boards of physical therapy. Moreover, the guidelines and recommendations included in this resource support a consistent scope of practice and standard of care, regardless of the delivery mechanism.

Three Things to Remember if You Get Sued

"The first thing we do, let's kill all the lawyers" – William Shakespeare

Some people just don't like lawyers. I get it. This is especially true if you work in a profession where there is a constant threat of lawsuits from aggrieved patients. As a defense attorney, I know first-hand that people file frivolous lawsuits all the time. Just because someone files a lawsuit against you does not mean you actually did anything wrong. However, even if you are confident that you acted properly, lawsuits can be scary, stressful, and expensive. For people who have experienced this, the stress can be compounded if you subsequently receive correspondence from the Board indicating that you are being investigated for claims relating to the lawsuit. However, if you understand the process, there is nothing to be afraid of. The following are three things you need to know if a lawsuit is filed against you:

1. Make sure to report any lawsuit to the Board.

The bi-annual renewal application issued by the Board asks if the applicant has any pending legal claims. Often, this is how the Board learns of pending legal action against a credential holder. However, 201 KAR 22:053, Section 1(1)(e) requires any PT or PTA to report to the Board any "civil judgment, settlement, or civil claim involving the credential holder's practice of physical therapy." Thus, all credential holders need to proactively report to the Board when a lawsuit is filed against them as opposed to waiting for the renewal application.

2. Just because the Board has opened an investigation does not mean it has formed an opinion on the merits of the case.

A common reaction among credential holders who learn the Board is investigating the claims brought in a lawsuit is fear that the Board has already accepted the plaintiff's allegations as true. This is not the case. The Board has a statutory duty to investigate all allegations that would potentially violate the applicable statutes or regulations. However, the Board understands that all allegations must be independently investigated and verified before it can take disciplinary action. While an investigation *could* lead to disciplinary action, it does not necessarily mean that it *will*.

3. The Board makes its own factual determinations and is not obligated to follow findings by a judge or jury in a civil matter.

The Board judges the merits of all complaints based upon the factual findings of its internal investigation. While it may inspect documents or depositions provided in a civil case, rulings rendered by judges or juries do not control the Board's ultimate decision as to whether or not discipline is warranted. A person who prevails in a civil action may ultimately be disciplined by the Board. Similarly, a person found liable in a civil case may not face any discipline by the Board.

2015 Continued Competency Audit It's That Time Again!!

In January of 2005, the Board first promulgated its administrative regulation that requires physical therapists and physical therapist assistants to complete continued competency for every license period. In mandating this requirement, the Board determined that evidence of continued competency was important in assuring safe and effective practices in the provision of physical therapy services. The Board also found that mandating continued competency was needed to bring the Physical Therapy profession to an equivalent level with other professions that have mechanisms in place to require demonstration of continued competency for licensure or certification.

To determine compliance with this requirement, the Board conducts a random audit every biennium of a minimum of 5% of the physical therapists and 5% of the physical therapist assistants who renewed their credential that year. In addition to the random audit, the Board audits all credential holders who were disciplined by the Board for continued competency deficiencies in the last biennium; one Board member selected randomly; and all credential holders for whom Board staff does not have proof of completion of the Jurisprudence Examination and/or the HIV/AIDS Continuing Education requirements.

The continued competency audit for 2015 will begin before June 1, and those selected for the audit will be mailed a certified return receipt letter advising that they were selected to participate in the audit and they are to send the Board a tracking form along with proof of contact hours within 30 days of the date of the letter.

Unless an extension of time has been provided to the credential holder, the Board will initiate the complaint process against any audited credential holder who fails to timely submit proof of meeting the continued competency requirements within 30 days of the final receipt date stated in the audit notice letter. Board staff shall report to the Board all credential holders who are non-compliant with the 30-day deadline so the Board may determine whether the discipline process established in 201 KAR 22:052 should be applied.

If you are selected to participate in the audit this year, don't ignore this notice!! Complete the tracking form and submit this information to the Board within the 30-day time window so it may be reviewed by Board staff without delay.

Those credential holders who are determined to be deficient in satisfying their continued competency requirements will be required to submit their CE/CC documentation with the Board through FSBT's aPTitude Continuing Competence Verification System both in the current and subsequent biennium.

Exploring a Physical Therapy Interstate Licensure Compact Part II

In the Board's last newsletter, we highlighted the fact that the 2013 Delegate Assembly for the Federation of State Boards of Physical Therapy (FSBPT) supported its Board of Directors in exploring mobility and portability of the practice of physical therapy through an Interstate Licensure Compact. In late 2013, members of a Physical Therapy Licensure Compact Task Force ("Task Force") were appointed by FSBPT to examine whether the adoption of such a Compact would help reduce unnecessary administrative hurdles related to the practice of physical therapy across state borders, as well as assist clients of physical therapy services in obtaining increased access to care.

Following extensive discussion conducted over several meetings, the Task Force recommended to FSBPT that a "Drafting Team" be assembled to develop language that may serve as a Model Interstate Compact for all physical therapy licensing boards. Following two meetings in 2014 and two meetings earlier this year, the Drafting Team submitted language for a Model Interstate Compact to FSBPT's Board of Directors on April 13, 2015. The Drafting Team further recommended that FSBPT move forward with the implementation of a Physical Therapy Licensure Compact, provided that FSBPT is willing to subsidize its operation.

A final draft of the Model Compact is scheduled to be distributed throughout this summer seeking input from various stakeholders and interested parties, including FSBPT's member boards, APTA's state chapters and sections, the American Telemedicine Association, traveling companies, Federal Agencies, the Office of Inter-Government Affairs, and large heath care organizations. Prerecorded webinars on FSBPT's public website are also planned which will explain the background and rationale for a Compact, its conceptual model and language, and the next steps in its possible implementation.

The members of Kentucky's Board of Physical Therapy are closely monitoring these developments. Board representatives are scheduled to attend both FSBPT's Leadership Issues Forum in August and FSBPT's Annual Meeting in October to gather more information about this important initiative before examining whether the adoption of the Interstate Compact for Physical Therapy would further enhance its mission of public protection in the Commonwealth of Kentucky.

The Board will continue to provide updated information relative to this initiative as it becomes available.
