The Board reviewed with approval the IPTPC report submitted by Brian Fingerson.

## **Update on Monitoring Probations**

Update on monitoring probations was given for the following with approval: April Coldiron, PT; James Rick Roe, PT; Ron Cole, PT; Mary Beth Barcus, PT; Malton Schexneider, PT. Mr. Schexneider's monitoring compliance has been referred to the Complaints Committee, as above.

#### **Board and Administrative Business**

Gail Parker inquired why Occupational Therapists were going to a foot/ankle continuing competency course and asked if this is infringing on physical therapy boundaries. The Board has no control of who attends continuing competency courses and advised that she contact the ATPA if she has more concerns.

Troy Grubb presented a question from Ann Marciniak about dual POC that both OT and PT can use. They are two different disciplines and need to have separate POC

Jennifer Rea asked what the role of a physical therapy tech should be and the definition of direct onsite supervision. 201 KAR 22:053 Section 1 state: (12) "On-site supervision" means immediate physical accessibility within the same building and (16) "Supportive personnel" means a person assisting in the provision of direct physical therapy patient care who is not credentialed by the board. It is the responsibility of the supervising physical therapist to: Section 4(2) Not delegate procedures or techniques to the physical therapist assistant or supportive personnel if it is outside his or her scope of training, education or expertise, and (3) Be responsible for: (d) Evaluating the competency of the physical therapist assistant and supportive personnel.

The Board reviewed the Declaratory Opinion regarding the Discharge summary and has accepted the final version for publication.

The Board received a written response on 201 KAR 22:053 amendment filed November 15, 2009. This allows all students (CAPTE or Foreign educated) that are in the process of fulfilling their clinical education be held to the same standards.

The Board discussed with David Pariser, KPTA liaison, about filing a bill to amend KRS 327.025, 040, 070, 080 and 990. David Pariser will discuss with the KPTA the sections of the law and solicit their support.

A letter was reviewed from Jeffrey Taylor-Haas, PT regarding a sanction on his license and why it is a permanent sanction. There is no provision in the law that allows expungement of a disciplinary action.

### Other Board Matters

Margaret Blain submitted a written report on the FSBPT Annual Meeting in San Diego, CA October 1-4, 2009.

Ron Barbato and Troy Grubb made a report on the FARB Attorney Certification Seminar in Chicago, IL, October 2-4, 2009.

FARB Annual Forum in Las Vegas, NV January 29-31, 2010. Mark Brengelman and Becky Klusch were approved to attend at the September Board meeting.

Board members reviewed the lists of persons issued a license, certificate as well as examinees and reinstatements since the last meeting. Lists are attached to these minutes.

The Board reviewed the financial statement ending October 30, 2009.

The Executive Director referenced the issue of Board members' actual and necessary expenses for instate and out-of-state travel. This issue will be revisited at the January meeting.
