A motion was made by Peggy Block, seconded by Ron Barbato to require Tami R. Mathis, a PTA reinstatement applicant with the following conditions: re-examination of the NPTE, three month onsite supervision within one year of the date of notice. All were in favor.

## **Update on Monitoring Probations**

William Kyle Clark, PTA, requested relief from the final monitoring visit. The Board denied the request due to no provisions in the Settlement Agreement that allow for relief. Peggy Block will make the final monitoring visit in October.

Janice Kuperstein, PT, will converse with the monitor of Amy Farmer, PT, to clarify the monitoring report.

### **Board and Administrative Business**

A motion was made by Ron Barbato, seconded by Peggy Block to approve the Remediation Plans for KW with the provision of showing proof of completion of the comprehensive review course. Motion carried.

### **Other Board Matters**

A credential-holder inquired whether a physical therapist may switch a patient from an O2 compressor to a portable tank to transport patient to therapy. Assessing cardiopulmonary status of a patient is clearly within the Physical Therapy Scope of Practice and is an essential part of clinical practice in all settings. Accordingly, as long as the physician has written oxygen orders that do not restrict switching from a compressor to a portable tank, it is appropriate for a physical therapist or appropriately trained and supervised support personnel to perform this activity.

The Board may clarify 201 KAR 22:053 Reassessments "on directly observed by the physical therapist" next time the regulation is amended.

A motion was made by Troy Grubb, seconded by Peggy Block, to change proposed KRS 327 legislative revisions by removing the statutory language "Advisory Opinions" in KRS 327.040, retain the original language of KRS 327.070(2) (c) - (d), and remove "Permanently" in (1) (c). Motion carried 5/0.

Fixed Date Testing – Chair showed a Power Point on why going to fixed date testing was necessary due to breach of the NPTE. Board had open dialogue for informational purpose only. More input will be received at the FSBPT meeting in Charlotte, N.C.

Supportive Personnel Committee – Ron Barbato is in discussion with the KPTA regarding the members that have volunteered to work on the committee.

Ron Barbato gave a report from the meeting with the KPTA on September 8, 2011 on KRS 327 changes and the discussion of the political climate in going forward during the next legislative session.

A motion was made by Ron Barbato, seconded by Peggy Block to appoint Troy Grubb as Chair for the coming year, and Linda Pillow to rotate onto the Complaint Committee. All in favor.

A motion was made by Linda Pillow, seconded by Chuck Clark to fund Becky Klusch, Peggy Block and Troy Grubb to attend the FARB Forum in Sarasota, Florida on January 27-29, 2012. Motion carried.

Board members reviewed and approved the lists of persons issued a license, certificate as well as examinees and reinstatements since the last meeting. Lists are attached to these minutes.

The Board reviewed the financial statement for fiscal year ending August 31, 2011.
