- 7 NECESSITY, FUNCTION, AND CONFORMITY: KRS 327.040(11) authorizes the Board of
- 8 Physical Therapy to promulgate and enforce reasonable administrative regulations for the
- 9 effectuation of the purposes of KRS Chapter 327. KRS 327.040(1) requires the board to
- determine if physical therapist applicants meet the qualifications and standards required
- by KRS Chapter 327. KRS 327.040(13) authorizes the board to promulgate administrative
- regulations regarding the qualifications for physical therapist assistants. This
- administrative regulation establishes the criteria for eligibility, methods, and procedures of
- 14 qualifying for a credential to practice physical therapy in Kentucky.
- 15 Section 1. An application shall be accepted for credentialing as a physical therapist or
- physical therapist assistant based on successful completion by the applicant of one (1) of
- 17 the following processes:
- 18 (1) Examination;
- 19 (2) Endorsement; or
- 20 (3) Reinstatement.

- 1 Section 2. Examination Candidate.
- 2 (1) To be eligible for the examination, the applicant for licensure as a physical therapist
- 3 shall:
- 4 (a) Have successfully completed the academic and clinical requirements of a
- 5 physical therapy program accredited by CAPTE;
- 6 (b) Submit certification of completion by the educational administrator of that
- 7 program;
- 8 (c) Have successfully completed the Jurisprudence Exam;
- 9 (d) Submit a complete Application for credentialing that includes a photo taken
- 10 within one (1) year;
- (e) Submit the correct, nonrefundable fee as required in 201 KAR 22:135;
- 12 (f) Effective six (6) months after the board receives an Originating Agency Number
- 13 from the Federal Bureau of Investigation, submit to the board a completed nationwide
- criminal background check as required by KRS 327.310 with the background investigation
- 15 completed no later than six (6) months prior to the date of the filling of the application.
- 16 (g) If applicable, submit on an Applicant Special Accommodations Request Form a
- 17 request for a reasonable accommodation in testing due to a documented disability; and
- 18 (h) Register for the NPTE examination.
- 19 (2) To be eligible for the examination, the applicant for certification as a physical
- 20 therapist assistant shall:
- 21 (a) Have successfully completed the academic and clinical requirements of a physical
- 22 therapy or physical therapist assistant program accredited by CAPTE; and
- 23 (b) Complete the requirements of subsection (1)(b) through (h)of this section.

- 1 (3) Effective July 1, 2012, after six (6) failed attempts at either the physical therapist or
- 2 physical therapist assistant examination, or combination thereof, in any jurisdiction, an
- 3 applicant for licensure or certification shall not be eligible to register for any additional
- 4 examinations.
- 5 Section 3. An applicant for credentialing who is registered for the examination in another
- 6 jurisdiction shall:
- 7 (1) Meet the eligibility requirements of Section 2 of this administrative regulation; and
- 8 (2) Register with the FSBPT Score Transfer Service to have results submitted to
- 9 Kentucky.
- Section 4. To be eligible for a temporary permit, the candidate shall:
- 11 (1) Meet the qualifications of Section 2 or 3 of this administrative regulation, except for
- the retake provisions in Section 2(3) of this administrative regulation;
- 13 (2) Complete a Supervisory Agreement for Applicant with Temporary Permit with one
- 14 (1) or more physical therapists; and
- 15 (3) Have not failed either the physical therapist or physical therapist assistant
- 16 examination in any jurisdiction.
- 17 Section 5.
- 18 (1) Upon issuance of a temporary permit, the physical therapist or physical therapist
- 19 assistant applicant shall practice only under the supervision of a physical therapist
- currently engaged in the practice of physical therapy in Kentucky who:
- 21 (a) Has practiced in Kentucky for more than one (1) year; and
- (b) Has an unrestricted license.
- 23 (2) A supervising physical therapist:

- 1 (a) Shall be on-site at all times during the practice of the applicant with a temporary
- 2 permit;
- 3 (b) Shall be responsible for the practice of physical therapy by the applicant with a
- 4 temporary permit;
- 5 (c) Shall review, approve, date, and co-sign all physical therapy documentation by the
- 6 applicant with a temporary permit;
- 7 (d) May designate an alternate supervising physical therapist who meets the
- 8 qualifications of subsection (1)(a) and (b) of this section. The alternate supervising
- 9 physical therapist shall sign and date written documentation of the acceptance of the
- responsibility as identified in paragraph (a) through (c) of this subsection; and
- (e) Shall notify the board immediately if the supervisory relationship is terminated.
- 12 (3) The applicant with a temporary permit shall:
- 13 (a) Disclose the applicant's temporary credential status to all patients prior to initiating
- 14 treatment;
- 15 (b) Sign documentation with temporary permit number and designation as required in
- 16 201 KAR 22:053, Section 5(5)(a) or (b); and
- 17 (c) Notify the board immediately if the supervisory relationship is terminated.
- 18 (4) The temporary permit shall expire the earlier of:
- 19 (a) Six (6) months from the date of issuance; or
- 20 (b) Notice of exam results by the board. A temporary permit holder who is registered
- 21 for the examination in another jurisdiction shall register with the FSBPT Score Transfer
- 22 Service to have results submitted to Kentucky within forty-eight (48) hours of the release
- of the exam results.

- 1 Section 6. A physical therapist applicant who meets the qualifications for physical therapy
- 2 licensure by examination may become a special candidate for physical therapist assistant
- 3 certification by examination.
- 4 Section 7. To be eligible for credentialing by endorsement, the applicant shall:
- 5 (1) Have successfully completed the academic and clinical requirements of a physical
- 6 therapy or physical therapist assistant program accredited by CAPTE;
- 7 (2) Meet the requirements established in Section 2(1)(b) through (f) of this
- 8 administrative regulation;
- 9 (3) Have successfully completed the NPTE or its equivalent, predecessor examination
- and register with the FSBPT Score Transfer Service to have results submitted to Kentucky:
- 11 (a) A passing score in Kentucky for the person who took the NPTE prior to July 1, 1993,
- shall be at least equal to the national average raw score minus one and five-tenths (1.5)
- standard deviation set equal to a converted score of seventy-five (75); or
- (b) After July 1, 1993, a passing score shall be the criterion referenced passing point
- recommended by the FSBPT set equal to a scaled score of 600;
- 16 (4) Have an active credential in this profession in another jurisdiction; and
- 17 (5) Have verification of credentials showing the credential has never been revoked,
- 18 suspended, placed on probation, or is not under disciplinary review in another jurisdiction
- 19 upon application.
- Section 8. To be eligible for reinstatement, the applicant shall meet the requirements in
- 21 201 KAR 22:040.
- Section 9. A credential issued by the board shall be in effect until March 31 of the next odd-
- 23 numbered year.

- 1 Section 10. A foreign-educated physical therapist shall comply with the provisions of 201
- 2 KAR 22:070.
